✓j. The trustees are authorized to borrow moneys for the purpose of the trust from banks, financial institutions and others with or without security and in respect of any other assets both movable and immovable belonging to the trustees as security and execute under the need of agreement or deed or mortgage for the purpose of offering the assets of the trust as security in respect of such borrowing.

k. The trustees are entitled to mortgage the funds and moneys and other assets of the trust in any immovable properties as may be found necessary from time to time and have the right to sell, lease, mortgage or dispose of such assets and immovable properties as may be found necessary in this behalf on approval of the trust board and any such documents/contracts shall be signed by the chairman/Managing Trustee.

l. The trustee or Trustees are authorized to acquire by purchase or by lease, land, buildings, agricultural land and other properties for the purpose of the objects of the Trust. The trustee or trustees are authorized to construct on their land or lease land, superstructure for the purpose of the object of the trust and for the said purpose all the documents for obtaining licences from corporation, Municipality or local bodies, shall be signed by the Chairman/Managing Trustee.

m. To Delegate by powers of attorney or by a resolution passed in this behalf or otherwise any of the powers herein above specified, to any trustee or trustees or any other person or persons for effectively and smoothly carrying out the objects of the trust and for proper administration of the trust.

✓n. The trustees are entitled to make rules for the purpose of the objects of the trust, but such rules shall not be against the objects of the trust as stated above. Any amendment to any clause of this trust deed shall be carried out only with the approval of the trustees, subject to the provision of law.

✓o. The trust is entitled to collect fees for the purpose of the objects of the trust.

p. To collect donation, gifts in cash or kind from any person, registered bodies or firms Adhenems limited company or from Government either by aids to trust or getting lands by donations or by assignments or for long lease and other general

public irrespective of caste, religion, sex etc and use the same towards fulfilling aims and objects of the trust.

q. To raise/borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security of movable or immovable as the management think fit.

r. Whenever urgency or imminent circumstances arise any resolution in writing circulated amongst all Trustees and their view in writing can be considered a majority view and shall be as valid and effectual as if its had been passed at a meeting of the trustees duly called and convened.

s. To open and close accounts with banks, to operate upon any such accounts to pay and draw money from such accounts and otherwise deal with same and the powers in this behalf may be exercised jointly by Chairman/Managing Trustee and Dr.K.Karthik the other member of the Board of Trustees are empowered by a resolution of the trustee/s in a meeting held under the presidentship of the Chairman/Managing Trustee.

GENERAL:-

1. The income of the funds of the trust shall be solely utilized towards its objects and no portion of it shall be utilized for the payment to trustees by way of profit, interest, dividend, etc.,

2. The benefit of the trust are open to all persons irrespective of caste, religion, sex, etc.,

3. No activities of the trust shall be carried, out side India.

4. The trustee/s shall from time to time have power to frame Rules for the proper conduct of the affairs of the Trust and alter, named any of the powers vested in the administration of the trust, herein but they shall not have power to amend any of the objects.

5. This DEED of Trust may be altered, amended or otherwise wanted, for the purposes of facilitating the carrying out of the objects of the Trust by unanimous

decision of the board of trustees and with the approval of the Commissioner of Income tax, after the trust is registered under the Income Tax Act.,

6. Removal of Trustees: Board of Trustees may by the majority vote of all the Trustees for the time being except the Trustee proposed to be removed, remove any Trustee if found that the Trustee is guilty of services, misconduct in relation to the Trust activities or if he/she is acting in a manner which is detrimental to the objects of the Trust. In all other aspects this trust shall be governed by the provisions of Indian Trust Act.

7. CYPRES: In the event of the trust not being able to function in fulfillment of the object, after discharging all the liabilities, the trustees shall utilize the assets of the trust to any public charitable institution or institutions having similar objects.
